# IN THE YEAR TWO THOUSAND AND SEVENTEEN

NINE HUNDRED AND THIRTY-SIXTH AMENDMENT TO CHAPTER 86 OF THE REVISED CODE OF ORDINANCES OF THE CITY OF HOLYOKE, MASSACHUSETTS 1997

## AN ORDINANCE

Be it ordained by the City Council of the City of Holyoke as follows:

**SECTION 1.** Section 86-10 entitled “Penalties” of Article I entitled “In General” of Chapter 86 entitled “Traffic and Vehicles” of the Revised Code of Ordinances of the City of Holyoke, Massachusetts, 1997, as amended, is hereby further amended by the following:

### DELETING:

Section (b): Any person violating the following parking regulations shall be subject to a fine as set forth in the schedule set out below. The following violations shall be subject to a fine of \$15.00, with the exception of Code 3—Winter parking regulations, which shall be subject to a fine of \$25.00 and Code 20—Overtime, which shall be subject to a fine of \$10.00 and Code 22—Fire lane, which shall be subject to a fine of \$50.00, if paid within 21 days of receipt of notice of hearing, and \$20.00 if paid thereafter but before the parking clerk reports to the registrar of motor vehicles pursuant to M.G.L.A. c. 90, § 20A, as amended, and \$35.00 if paid subsequent thereto:

### ADDING in its place:

Section (b): Any person violating the following parking regulations shall be subject to a fine as set forth in the schedule set out below. The following violations shall be subject to a fine of \$25.00, if paid within 21 days of receipt of notice of hearing, and \$30.00 if paid thereafter but before the parking clerk reports to the registrar of motor vehicles pursuant to M.G.L.A. c. 90, § 20A, as amended, and \$45.00 if paid subsequent thereto:

Exceptions: Code 3—Winter parking regulations, which shall be subject to a fine of \$35.00; Code 20—Overtime, which shall be subject to a fine of \$20.00; and Code 22—Fire lane, which shall be subject to a fine of \$50.00

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** This ordinance shall take effect on the date of passage.
