Ordered, Ordered that the council adopt an ordinance requiring city council approval of any license agreement for the use of city-owned real property where the term of such agreement exceeds thirty (30) days. The Council enacted such an ordinance on February 2, 2016, however, the provision inserted as Section 2-349(c)(1) does not appear currently appear in the print or online Municode. It appears the provision was not included in the legal form rewriting "Division 3. Purchasing Department" and adopted by the City Council on September 21, 2016. The legal form may have been based on a version of Division 3 in effect prior to the enactment of Section 2-349(c)(1). In City Council, September 5, 2018. Received and referred to the Ordinance Committee.

In City Council, on October 16, 2018, the report of Committee received and the Ordinance passed its first reading.

The Ordinance passed its second reading.

The Ordinance was passed to be enrolled.

The Committee has considered the same and find that it is truly and properly enrolled.

IN THE YEAR TWO THOUSAND AND EIGHTEEN

ONE HUNDRED FIFTY-NINTH AMENDMENT TO CHAPTER 2 OF THE REVISED
CODE OF ORDINANCES OF THE CITY OF HOLYOKE, MASSACHUSETTS 1997

AN ORDINANCE

Be it ordained by the City Council of the City of Holyoke as follows:

SECTION 1. Section 2-336 entitled “Real property disposition or acquisition” of Division 3 entitled “ Purchasing Department” of Article III entitled “Departments” of Chapter 2 entitled “Administration” of the Revised Code of Ordinances of the City of Holyoke, Massachusetts, 1997, as amended, is hereby further amended by the following:

ADDING:

(c) *Licenses.*

- (1) Any license agreement for the use of land or other real property owned by the City of Holyoke for a term that exceeds a total of thirty (30) days shall be approved by a 2/3 vote of the City Council.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. This ordinance shall take effect on the date of passage.
