# IN THE YEAR TWO THOUSAND AND EIGHTEEN

NINE HUNDRED AND FORTIETH AMENDMENT TO CHAPTER 86 OF THE REVISED CODE OF ORDINANCES OF THE CITY OF HOLYOKE, MASSACHUSETTS 1997

## AN ORDINANCE


