# IN THE YEAR TWO THOUSAND AND EIGHTEEN

NINE HUNDRED AND FORTY-SIXTH AMENDMENT TO CHAPTER 86 OF THE REVISED CODE OF ORDINANCES OF THE CITY OF HOLYOKE, MASSACHUSETTS 1997

## AN ORDINANCE

Be it ordained by the City Council of the City of Holyoke as follows:

**SECTION 1.** Section 86-321 entitled "Schedule I - Parking" of Article IX entitled "Schedules" of Chapter 86 entitled "Traffic and Vehicles" of the Revised Code of Ordinances of the City of Holyoke, Massachusetts, 1997, as amended, is hereby further amended by the following:

DELETING in its entirety:

<u>Location</u>	<u>Side</u>	<u>From</u>	<u>To</u>	<u>Type</u>
Oak St.	Westerly	A point 67 feet southerly of Dwight St.	A point 22 feet further southerly	Handicap plate # 93490 only


ADDING in its place:

<u>Location</u>	<u>Side</u>	<u>From</u>	<u>To</u>	<u>Type</u>
Oak St.	Westerly	A point 87 feet southerly of Dwight St.	A point 22 feet further southerly	Handicap plate # 93490 only

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** This ordinance shall take effect on the date of passage.
