
ADDING:

Suffolk St	Westerly	Elm St. intersection	A point 30 ft West of Elm St	No parking from here to corner

Walnut St	Northerly	A point 10 ft South of the Juvenile Court parking lot driveway	A point 10 ft. North of the Juvenile Court parking lot driveway	No parking between signs

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
