# IN THE YEAR TWO THOUSAND AND NINETEEN

NINE HUNDRED AND NINETY-SECOND AMENDMENT TO CHAPTER 86 OF THE REVISED CODE OF ORDINANCES OF THE CITY OF HOLYOKE, MASSACHUSETTS 1997

## AN ORDINANCE

Be it ordained by the City Council of the City of Holyoke as follows:

**SECTION 1.** Section 86-212 entitled "Speed" of Article IV entitled "Operation of Vehicles" of Chapter 86 entitled "Traffic and Vehicles" of the Revised Code of Ordinances of the City of Holyoke, Massachusetts, 1997, as amended, is hereby further amended by the following:


### ADDING:

Sec. 86-212 (c) Pursuant to the authority granted under Section 193 of Chapter 218 of the Acts of 2016 "An Act Modernizing Municipal Finance and Government" and MGL Ch. 90, Sec.18B, the City of Holyoke establishes a 20 mph Safety Zone in the vicinity of the Dean School and athletic field on Main Street beginning at the northerly entrance drive to the school and extending 1,000 feet to the South.

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** This ordinance shall take effect on the date of passage.
